In accordance with the Department of Education Contributions, Charges and Fees Policy, schools can request up to a maximum contribution of \$235 per student for years 7-10. The Jurien Bay DHS School Board has approved the amount of \$235 per student for 2024. These contributions are used towards the cost of materials, services and resources used by students in the educational program. In some learning areas, students/parents may negotiate with staff to complete a project that incurs additional materials. YEAR 10 CHARGES FOR OPTIONAL ACTIVITIES THROUGHOUT THE YEAR

Charges apply for the extra cost optional activities (eg incursions and excursions) that are part of an education program and which 'contributions' do not cover. All activities outlined overleaf are optional and if no payment is received, a different activity will be provided for your child. The School Board recognises the value of these types of activities and seeks to support teachers who coordinate them as part of their teaching programs.

The School Board has approved all 2024 charges for extra activities. The estimated costs provided are at an upper limit and will not exceed the amount shown. If a particular event does not happen within the school year, no charges for that event will apply.

Payment of the extra cost optional charges is not required at the time of finalising payment of 'contributions'. Where staff arrange extra cost optional activities, payment will be requested immediately prior to it happening.

STUDENT ALLOWANCES 2024

The Secondary Assistance Scheme is available to secondary students whose parents hold Centrelink Family Health Care or Pensioner Concession Cards or Veteran's Affairs Pensioner Concession Cards. The Secondary Assistance Scheme consists of a \$235.00 Educational Program Allowance which is paid directly to the school and a Clothing Allowance of \$115.00 which is paid to the parent.

Students are not eligible for the Secondary Assistance Scheme in the year in which they turn 19 years of age or older and/or if they have previously received the allowance when enrolled at another school in the current year.

REFUND OF CONTRIBUTIONS AND CHARGES

When a student transfers to another school, arrangements will be made to forward a pro-rata portion of their 'contributions' to their new school. Alternatively, a refund can be arranged. The refunded amount will be based on a pro rata rate as stipulated by the Department of Education.
